I know that we're living in a time of 'social distancing' but it is easy to convene a conference call. The N.C. State Conference continues to suffer from a lack of communication. It is impossible to create an environment of support without clear, concise communications!

Madam Sweetlove et al,

Thank you for your email. I must say that after the activities of the past few weeks and the Regional meeting last night I am not surprised by this email nor the tone (title in all capital letters and sentences ending in exclamation points, which sets forth a hostile communication in an electronic environment). I agree with you that one of the critical components of leadership is communication, CLEAR communication. On September 1, 2020 when I sent two texts to you, one at 6:33 am and the other at 3:26 pm asking if you had time to get on a call with me, you never responded. I did not hear anything more from you until September 22, 2020 when you asked if the dates we scheduled for the State Convention were the pre-scheduled/yearly time to which I responded yes. That being said as to your

Item 1: the State Conference did not identify anyone to take any role. That was done by National. What I did do, was to confer with Dominik Whitehead and Jamal Watkins, who were set to send a person into NC as Director. I had the good sense to do some vetting as I did back in 2018 to ensure the person would be a good fit. When I discovered that was not the case, I recommended a person to serve as the State Director Director and he was hired. The State Conference had no other part to play nor is the State Conference paying his salary hence I am really not clear of where this reprimand is coming. There was never a communication sent from National regarding the hire that they made. Had that occurred it would have been disseminated to the State Conference as it was in 2018.

As to your second item, Madam Administrator, the dates for the next Executive Committee meeting and State Conference were discussed in the July 18, 2020 Zoom call that you were on and to my understanding that zoom meeting was hosted with Carmen Watkins zoom credentials from the National NAACP signed in by our Regional Director Kevin Myles who turned over hosting duties to Daphne Holmes-Johnson. I ask that you review that recording as it is in National's possession.

To add further clarity, I have convened a few necessary Conference calls and a very distinct pattern has emerged. Those whom you communicate with are habitually absent from those calls. To the point you make about the State Conference continuing to suffer from a lack of communication, what does continue that makes it impossible to create an environment of support is when you have insecure people playing the victim in key positions. Their desire is to maintain a status quo that will keep them comfortably dysfunctioning in those roles and protecting their positions that have outgrown them.

It grieves me to say this Madam Sweetlove but I maintain that you came to the NC NAACP with a bias and the bias still remains. If you cannot get beyond THAT bias, this conference will remain as it is.

Whoever you are getting your information from, does not have the best interest of this State Conference at heart but the Lord does.

As I said last night, If we are to make any lasting contribution to the work of justice, give any valuable input to the mission of equity or experience any viable and valuable outcomes from the efforts we make to denounce discrimination or racism in any of its hideous forms, it will be brought to pass by the chanting of the seven words, Thy will LORD and not mine be done.

What is being done here is NOT the Lord's will.
